## **BOWERMAN LANDFILL**

The Hearing Board will be holding proceedings to consider the granting of a regular variance from South Coast AQMD Rules and Regulations and the adoption of a final compliance date for Landfill Gas Collection System, Landfill Condensate/leachate Collection, and Landfill Gas Flare System at OC WASTE & RECYCLING, FRANK R. BOWERMAN LANDFILL (Bowerman Landfill), 11002 Bee Canyon Access Road, Irvine, California, 92679. Bowerman Landfill anticipates excess emissions as a result of this variance. The exact nature and extent of these estimated excess emissions, as well as other potential pollutants, are to be determined by the Hearing Board.
